

EMAIL CONTACT PRIVACY NOTICE

When you contact us:

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and securely stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will not be shared or provided to any third party.

The Council's Right to Process Information:

General Data Protection Regulations Article 6 (1) (a) (b) (c) (d) and (e)

- Processing is with consent of the data subject or
- Processing is necessary in accordance with a contract of employment between the data controller and the data subject or
- Processing is necessary for compliance with a legal obligation or
- Processing is necessary to protect someone's life or
- Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

Information Security

Churchill and Blakedown Parish Council has a duty to ensure the security of personal data. We make sure your information is protected from unauthorised access, loss, manipulation, falsification, destruction, or unauthorised disclosure. This is done through appropriate technical measures, such as password protection and physical security, and adherence to our Data Protection Policy. Copies of all the council's policies can be seen on our website upon application.

We will only keep your data for the purpose it was collected for and only for as long as is necessary after which it will be deleted. You may request the deletion of your data held by Churchill and Blakedown Parish Council at any time.

Children

We will not knowingly process any data relating to a child (aged under 13) without the express parental/guardian consent of the child concerned.

Access to Information

You have the right to request access to the information we have on you. Information Correct

Information Deletion

Right to Object
