THE WORK OF THE PARISH COUNCIL DURING 2024/25

Road Safety - After a long campaign, we are pleased to see speed enforcement measures being implemented on Stakenbridge Lane to reduce speeding and enhance community safety. We also replaced the stolen solar kit on the speed warning sign on Rocky Lane.

Environmental Initiatives - We successfully obtained grant monies from Natural Networks to fund 70% of the costs for preparative groundworks and the planting of a biodiversity garden at the Signal Box. This project, nearly complete, will be named in memory of the late Jim Long, who was passionate about the Signal Box. The remaining 30% of the costs were funded by The Churchill and Blakedown Villages Trust.

Community Engagement and Appreciation - This year we celebrated the dedication of our village litter-picking ladies, Judy and Wendy, by gifting them with flower bouquets at Christmas. Their tireless efforts have significantly contributed to keeping our villages clean and beautiful.

Maintenance and Infrastructure - We have taken on a contractor to perform lengthsman duties, ensuring that drains and footpaths around the villages are kept clear and other matters are reported to WFDC or WCC. Additionally, we have removed redundant posts from around the parish and continue to monitor the bin situation.

Planning and Development - As consultees, we have provided valuable feedback on planning applications for tree works and property development, sometimes making objections based on our local knowledge. We have also employed specialist planning consultants, funded by grant monies, to review the Neighbourhood Plan for the next 10 years. This includes writing a design code to establish a design framework for future housing developments in the parish.

Community Contributions - We made over £2,000 worth of grants and donations to local causes, including:

- £500 to the Historical Society for a new village notice board
- £500 to the Churchill and Blakedown churches for grass cutting around the grounds
- £201 for the playground inspection at the Sports Pavilion
- £750 to the Villages Trust for planting the garden at the Signal Box
- £184 to the Friends of Churchill Church for the community dog show event

Public Amenities - We replaced the broken bench on Birmingham Road and continue to work with Instavolt and residents to address the issue of stolen EV charger cables. The lease to Instavolt generates income for the Parish Council that is earmarked for car park maintenance and future resurfacing. Our car park remains a valuable village asset, offering free short-term parking.

Consultations and Collaborations - We have consulted on highways matters, including double yellow lines at Gladstone Place and in Swan Close. We also monitored developments at Station Drive and consulted on the layout and housing mix, with WFDC taking our feedback into account. Additionally, we continue to work with the local policing team under the Community Charter, setting priorities for policing in our parish.

Signal Box Improvements As sole trustee of the Churchill & Blakedown Villages Trust, we have made several improvements at the Signal Box, with funding support gratefully received from the Norman Dawson Trust, including installing new heating and flooring. The meeting room served as a warm space from November 24 to March 25. The room is available for hire for parties and train enthusiasts and hosts a coffee morning on the 2nd and 4th Saturday of each month from 10am to 1pm.

PLANS FOR THE FUTURE

Consultation on the Revised Neighbourhood Plan - This summer we will be engaging with residents to gather feedback on the revised Neighbourhood Plan. Your views are invaluable to us, and we look forward to hearing your thoughts and suggestions to shape the future of our community.

Impact of Government's Devolution Plans - With the Government's devolution plans, some powers will be transferred from Whitehall to more mayor-led unitary authorities across England. Worcestershire is proposed to become a unitary authority by 2028, merging district councils into a single Worcestershire authority. This change will impact parish and town councils, including C&BPC, potentially requiring us to expand the services we provide.

Collaborative Efforts with Neighbouring Parishes In light of these changes, we plan to meet with neighbouring parishes to explore opportunities for collaboration on certain services. This is a new development for us, and we will keep you updated on our progress and any potential partnerships that may arise.

We are committed to keeping you informed and involved as we navigate these changes and work towards enhancing our community services. Your participation and feedback are crucial to our success.
